The Foundation's activities often complement the responsibilities carried out by its President, Prof. Michel Veuthey, in his capacity as Ambassador of the Sovereign Order of Malta to Monitor and Combat Trafficking in Persons, as well as in his role as Deputy Permanent Observer to the United Nations in Geneva. These mandates significantly enhance the Foundation's influence and credibility and facilitate the implementation of its mission through privileged access to high-level diplomatic, humanitarian, and academic networks.

HIGHLIGHTS OF 2025

13-14 January 2025

Preparatory Meetings for the High-Level Conference on Trafficking in Human Beings scheduled for 10 December 2025

Magistral Palace and Pontifical Gregorian University, Rome (Italy)

The Foundation provided financial support for the travel of its President, Michel Veuthey, who also serves as Ambassador of the Sovereign Order of Malta to Monitor and Combat Trafficking in Persons, in order to participate in two key meetings held in Rome as part of the organization of the conference scheduled for 10 December 2025.

These meetings made it possible to coordinate the logistical, scientific, and institutional preparation of the event and to strengthen cooperation with leading stakeholders.



The first meeting, held on 13 January at the Magistral Palace of the Sovereign Order of Malta, brought together H.E. Ambassador Giampaolo Cantini, Secretary General for Foreign Affairs of the Sovereign Order of Malta, Ambassador Michel Veuthey, and Kevin Hyland, OBE, LL.M., co-organizer of the conference and former UK Independent Anti-Slavery Commissioner, currently CEO of Praeveni Global.

Discussions focused on the structure of the conference, the selection of speakers, the composition of panels, and the involvement of international stakeholders, with the aim of ensuring an inclusive, high-level event.

The second meeting, held on 14 January at the Pontifical Gregorian University, was attended by Professor and Father Hans Zollner, SJ, Director of the University's Institute of Anthropology (IADC), to finalise logistics, venue organisation, and the planning of the Conference panels.

These two meetings were instrumental in ensuring coordination among the three organisers, guaranteeing the scientific and logistical quality of the Conference, and affirming the Foundation's active role in supporting this initiative to combat trafficking in human beings.



11 March 2025

Webinar – Launch of the Mission89 Global Thematic Report on Trafficking in Sport

This webinar was organized on the occasion of the publication of the Mission89 *Global Thematic Report* dedicated to trafficking in human beings in the field of sport. It followed the side event held on 20 June 2024 during the 56th session of the United Nations Human Rights Council, which addressed the challenges of exploitation and trafficking within the sports industry.

The webinar also formed part of the ongoing series organised under *Ad Laudato Si'*, a collaborative network of international experts committed to combating trafficking in human beings, supported by the CUHD Foundation.

Lasting two hours, the webinar aimed to present the report's key findings and raise participants' awareness of the specific characteristics of human trafficking in sport. This phenomenon, which remains relatively little known and underreported, is nevertheless widespread at the global level.

The webinar also served as a platform for dialogue and exchange among survivors, experts, and institutional stakeholders engaged in the fight against trafficking. It opened with introductory remarks from Michel Veuthey, President of the Foundation and Ambassador of the Sovereign Order of Malta to the Monitor and Combat Trafficking in Persons.

Ms Lerina Bright, Executive Director and Founder of Mission 89, then presented the report, highlighting the mechanisms, risks, and responsibilities of stakeholders within the sports sector.

The discussions addressed trafficking in sport from multiple perspectives and underscored the importance of prevention, victim protection, and the accountability of sports organizations.



28 March 2025

Side Event: Human Trafficking, 25 Years after the Palermo Protocol – The Need for Real Action Making a Difference

During the 58th session of the United Nations Human Rights Council, this side event, co-organised by UNITAR and Ambassador Michel Veuthey, with the support of the Foundation, and held within the framework of the Foundation's *Ad Laudato Si'* initiative, marked the 25th anniversary of the Palermo Protocol.

The discussions highlighted a clear finding: despite near-universal ratification, trafficking in human beings continues to increase, revealing a significant gap between legal standards and their effective implementation. Speakers recalled the key achievements of the Protocol, including the establishment of an international definition of trafficking in human beings; the adoption of the “three Ps” approach (prevention, protection, and prosecution); the recognition of the principle of non-punishment of victims; and improved transnational cooperation. These advances have led to legislative harmonisation in more than 180 States.

However, the overall assessment was widely considered insufficient. Several structural shortcomings were identified, including:

- uneven implementation, particularly in States with limited resources or affected by crises;
- an excessive focus on prosecution to the detriment of prevention and victim protection;
- major gaps in victim identification and assistance, often made conditional upon cooperation with law enforcement authorities;
- limited action to address demand, notably in relation to sexual exploitation and global supply chains;
- a critical lack of financial resources, disproportionate to the profits generated by trafficking in human beings, estimated at USD 236 billion annually.



The Special Rapporteur on Violence against Women and Girls underscored the disproportionate impact of trafficking in human beings on women and children, emphasizing the need for a human rights-based approach that is sensitive to gender, age, and intersecting forms of vulnerability. She also recalled that the Palermo Protocol does not replace other international instruments, in particular the Convention for the Suppression of the Traffic in Persons and of the Exploitation of the Prostitution of Others.

A strong consensus emerged on capacity-building as a key priority, including the training of law enforcement officials, ranging from police and border authorities to judges, diplomats, and frontline practitioners, as well as improved use of technological tools and strengthened cooperation among States, international organizations, and civil society. Contributions from INTERPOL and several States illustrated the concrete impact of operational training programmes and regional cooperation mechanisms.

1 June 2025

Publication: Protecting the Fundamental Rights of Young Girls Victims of Trafficking – A Call to Action

As part of its research activities on trafficking in human beings and the protection of children's rights, the CUHD Foundation contributed to the publication *"Protecting the Fundamental Rights of Young Girls Victims of Trafficking: A Call to Action"*.

This publication highlights the particular vulnerability of girls to trafficking, exacerbated by poverty, gender-based discrimination, lack of access to education, humanitarian or climate-related crises, as well as the abusive use of digital tools by traffickers.

It analyses the main forms of trafficking affecting young girls, including sexual exploitation, forced domestic labour, and forced marriage, which are often combined and reinforced by oppressive social norms. The publication underscores the need to adopt a child rights-based approach, structured around the three pillars of the Palermo Protocol: prevention, protection, and prosecution.

This initiative illustrates the Foundation's concrete commitment to the protection of children's fundamental rights and to the prevention of their exploitation, particularly that affecting young girls.



19 June 2025

Side Event : Mobilizing Against Human Trafficking in Sports – Women’s Safeguarding & the Global Thematic Report

Within the framework of *Ad Laudato Si'*, a collaborative network of international experts committed to combating trafficking in human beings, the Foundation supported the organization of a side event during the 59th session of the United Nations Human Rights Council in Geneva, held a few days ahead of the UEFA Women’s Euro 2025 in Switzerland.

The objective was to shed light on trafficking and exploitation in sport, particularly affecting women and girls, and to promote effective protection measures.

The event brought together experts, representatives of sports organizations and governments, as well as athletes, to share analyses and experiences. Participants recalled that the vulnerability of athletes, particularly women and minors, remains high, that abuses of power within sport constitute a key driver of exploitation, and that the growth of women’s football creates new opportunities but also new risks.

The global thematic report presented during the session defined “trafficking in sport” along three dimensions: exploitation in sport, through sport, and around sport, including forced labour and sexual exploitation. Case studies illustrated the coercion exerted on athletes through promises of sporting careers, as well as the need to adopt prevention and response measures tailored to the sporting context and to gender-specific vulnerabilities.

Speakers emphasized the importance of training sports stakeholders, strengthening codes of conduct and reporting mechanisms, engaging federations and players’ associations, and developing inclusive and transparent policies.

The session concluded by stressing the need to combine awareness-raising, legislation, and international coordination in order to protect athletes and combat impunity, particularly in the context of international competitions.



8 July 2025

Intervention on the Link between Trafficking in Persons and Smuggling of Migrants – 25th Summer Course of the International Institute of Humanitarian Law (IIHL) San Remo (Italy)

As part of its awareness-raising and training activities on human trafficking, the Foundation supported the preparation of the course delivered by its President during the 25th Summer Course organised by the San Remo International Institute of Humanitarian Law.

The course consisted of a 90-minute lecture on the link between trafficking in persons and the smuggling of migrants, delivered to 23 participants from 14 countries (Burundi, China, France, Germany, Ghana, Italy, the Netherlands, Pakistan, Portugal, Saudi Arabia, Singapore, South Korea, Ukraine, and the United States). Participants included police officers, United Nations officials, military personnel, jurists, academics, NGO representatives, and international consultants.

The intervention provided a clear analysis of the distinctions between trafficking in human beings and migrant smuggling, while also highlighting their interconnections, shared routes, and the common vulnerabilities of affected populations. It further examined the root causes of these phenomena and the specific risks arising in armed conflict contexts, illustrated through examples such as the recruitment of child soldiers and the sexual exploitation of women and girls, as well as their long-term consequences.

Prof. Michel Veuthey concluded by emphasising the need for a comprehensive action plan built around cooperation, prevention, victim identification, protection, prosecution of traffickers, and the reintegration of survivors. He underlined the particular vulnerability of migrants and stressed that trafficking and smuggling are not confined to conflict zones or developing countries.

This intervention illustrates the CUHD Foundation's concrete commitment to combating trafficking, defending fundamental rights, particularly those of displaced persons, and, more broadly, promoting respect for international humanitarian law.



21-22 July 2025

Preparatory Meetings for the High-Level Conference on Trafficking in Human Beings scheduled for 10 December 2025

Rome (Italy)

As part of the organization of the Conference scheduled for 10 December 2025, marking the 25th anniversary of the Palermo Protocol, the Foundation provided financial support for the travel of its President, Michel Veuthey to participate in a series of high-level meetings held in Rome.

Accompanied by Kevin Hyland, OBE, LL.M., CEO of Praeveni Global and the first UK Independent Anti-Slavery Commissioner, Michel Veuthey participated in these consultations to advance the Conference's preparatory work.

On 21 July, Michel Veuthey and Kevin Hyland held successive meetings with H.E. Mr. Alberto Medardo Barranco Chavarría, Ambassador of Mexico to the Holy See; H.E. Ms. Florence Mangin, Ambassador of France to the Holy See; H.E. Fra' Emmanuel Rousseau, Grand Commander of the Sovereign Order of Malta; H.E. Ambassador Giampaolo Cantini, Secretary General for Foreign Affairs of the Sovereign Order of Malta; and H.E. Mr. Francesco Di Nitto, Ambassador of Italy to the Holy See.

On 22 July, further meetings were held with H.E. Mr. Everton Vieira Vargas, Ambassador of Brazil to the Holy See; H.E. Mr. Luis Pablo María Beltramino, Ambassador of Argentina to the Holy See; Dr. Anabel Inge, Deputy Head of Mission and Chargé d'Affaires of the Embassy of the United Kingdom to the Holy See; and H.E. Ms. Frances Collins, Ambassador of Ireland to the Holy See.



These consultations helped strengthen international cooperation and mobilize governmental support in preparation for the December 2025 Conference, which brought together State actors, international organizations, civil society, and religious organizations to reaffirm commitments and intensify action against trafficking in human beings.

30 July 2025

Publication on the Occasion of the World Day against Trafficking in Persons

On the occasion of the World Day against Trafficking in Human Beings, observed on 30 July 2025, Prof. Michel Veuthey, in his capacity as Ambassador of the Sovereign Order of Malta to Monitor and Combat Trafficking in Persons, together with the Foundation, published an awareness-raising brochure prepared by members of the Foundation's Secretariat.

The publication aimed to inform, raise awareness, and mobilize action around trafficking in persons, presented as a contemporary form of slavery affecting all regions of the world.

Based on the international definition set out in the Palermo Protocol (2000), the publication offered a clear and accessible explanation of the mechanisms of trafficking in human beings, from the acts committed and the means employed to the purposes of exploitation.

The publication highlighted the current realities of trafficking in human beings through recent and alarming data, pointing to the growing number of identified victims, the prevalence of forced labour and sexual exploitation, and the increasing involvement of organized criminal networks.

Beyond this assessment, the document identified the structural challenges that continue to hinder effective action against trafficking, including the persistent invisibility of victims, the impunity of perpetrators, insufficient training of frontline actors, and inadequate international cooperation. It also challenged certain stereotypes, recalling that trafficking affects women, men, and children alike, all exposed to multiple and intersecting vulnerability factors.

Finally, the publication fully aligned with the mission of the Foundation to promote human dignity and defend fundamental rights. It called for collective and coordinated action grounded in prevention, victim protection, access to justice, and the empowerment of survivors, mobilizing all stakeholders from the local to the international level.



October 2025

Launch of the Foundation's New Website

13-14 October 2025

Introductory Course on International Humanitarian Law

Université Côte d'Azur, Trotabas Campus, Nice (France)



The CUHD Foundation made possible the preparation of a 10-hour introductory course on International Humanitarian Law (IHL), which took place from 13 to 14 October 2025 and was delivered by the President of the Foundation to Master's level students in Security, Defence and Economic Intelligence at Université Côte d'Azur.

During these sessions, the Ambassador presented the historical origins of International Humanitarian Law (IHL), its fundamental principles, the main actors involved, and the key legal instruments, illustrated by historical examples of practical application. Drawing on his extensive experience within the International Committee of the Red Cross, he shared his analyses and encouraged students to reflect on the future of IHL.

The sessions also raised students' awareness of the protection of vulnerable populations and of human rights violations, including trafficking in human beings in situations of armed conflict, emphasizing that respect for IHL and fundamental rights constitutes an essential safeguard for all.

This initiative forms part of the Foundation's ongoing efforts to promote human rights education in connection with international humanitarian law and the fight against trafficking in human beings.



12 November 2025

Preparatory Meetings for the High-Level Conference on Trafficking in Human Beings scheduled for 10 December 2025

A final series of diplomatic preparatory meetings for the High-Level Conference on Trafficking in Human Beings, supported by the Foundation, enabled President Michel Veuthey, in his capacity as Ambassador of the Sovereign Order of Malta to Monitor and Combat Trafficking in Persons, to meet with the following representatives:

- H.E. Ms. Joyce Napier, Ambassador of Canada to the Holy See, to formally invite her to the Conference and exchange views on issues related to trafficking in human beings.
- Ms Laura Hochla, Deputy Chief of Mission of the US Embassy to the Holy See, to discuss the venue of the Honourable Pamela Bondi, United States Attorney General.
- H.E. Mr. Giampaolo Cantini, Secretary General for Foreign Affairs of the Sovereign Order of Malta, to discuss the possibility of an audience with the Pope and to examine the potential participation of a high-level representative of the Holy See in the Conference.
- H.E. Mr. Francesco Di Nitto, Ambassador of Italy to the Holy See, to inform him of the participation of Pamela Bondi, United States Attorney General, in the Conference, and to assess the possible participation of the Italian Minister of Foreign Affairs, H.E. Mr. Antonio Tajani.

These meetings helped to strengthen the diplomatic and institutional partnerships essential to the success of the Conference and to ensure the participation of high-level representatives and key speakers.

10 December 2025

**International High-Level Conference on Human Trafficking

The International High-Level Conference held in Rome on the occasion of the 25th anniversary of the Palermo Protocol marked the highlight of the Foundation's activities in 2025. Conceived and led by Ambassador Michel Veuthey, in collaboration with Mr. Kevin Hyland, OBE, LL.M. (Praeveni Global), and Professor Fr. Hans Zollner (Institute of Anthropology, Pontifical Gregorian University), the initiative was not intended as a commemorative event, but rather as a call to action, aimed at examining the persistent gap between the robustness of international legal frameworks and the weakness of their effective implementation.

The idea for this Conference emerged at the end of 2024 and evolved through a lengthy process of development, marked by consultations, preparatory meetings, and strategic partnerships throughout 2025. The Foundation played a central role in this process as both sponsor and strategic partner, providing comprehensive financial and operational support (*see page 19 for details of the support provided*).



The event brought together more than 40 speakers representing all key stakeholders involved in the fight against trafficking in human beings and welcomed over 100 in-person participants, as well as approximately 500 online attendees. The Conference was structured around five thematic panels, addressing in turn existing institutional frameworks, implementation processes, the role of judicial systems and international cooperation, the centrality of victims and survivors, and the economic and preventive dimensions of human exploitation.

Among the speakers were government representatives, including H.E. Riccardo Paternò di Montecupo, Grand Chancellor of the Sovereign Order of Malta; The Honourable Pamela Bondi, United States Attorney General; and H.E. Stefano Pizzicannella, Italy's Special Envoy on Trafficking in Human Beings. The Conference also featured religious representatives, including H.E. Archbishop Marcelo Sánchez Sorondo and His Eminence Cardinal Fabio Baggio, C.S., as well as representatives of United Nations agencies (UNHCR, IOM), Special Rapporteurs, civil society organizations, the financial sector, NGOs, and international and national law enforcement agencies (Interpol, FBI, Irish National Police).

The discussions highlighted a widely shared assessment: despite a robust international normative framework, trafficking in human beings remains a major global crisis with moral, legal, economic, humanitarian, and security dimensions. Speakers recalled that less than 1% of victims are identified worldwide, and that prosecution and conviction rates remain extremely low in comparison with the profits generated by criminal networks. Several contributions underscored the need to move beyond declaratory commitments by strengthening law enforcement, improving inter-institutional coordination, and ensuring sustained investment in prevention and victim protection.

Particular attention was given to the heightened vulnerabilities of women, children, and displaced populations, as well as to the importance of genuinely victim-centred approaches based on trust, respect for human rights, and trauma-informed care.



The discussions also highlighted the decisive role played by non-State actors, civil society organizations, faith-based organizations, universities, the private sector, and financial institutions in the prevention of trafficking, as well as in the protection and rehabilitation of survivors.

Beyond the exchanges, the Conference identified several concrete follow-up priorities, including the development of training programmes, the strengthening of partnerships with international and academic organizations, and the use of monitoring and evaluation tools to track State and financial commitments. It also contributed to reinforcing existing anti-trafficking networks, particularly within the Sovereign Order of Malta, and reaffirmed the shared responsibility to translate legal and moral commitments into measurable impact.

The CUHD Foundation played a central role in the organization of the Conference by assuming responsibility for the following tasks:

- Management of personalized invitations, confirmations, and communications with speakers and participants;
- Support for the organization of speakers' travel, including financial assistance and booking coordination;
- Procurement and management of all logistical equipment required for the Conference;
- Design of visual materials and the official programme;
- Design, development, and online publication of the dedicated Conference website;
- Preparation and monitoring of the provisional and final budgets;
- Receipt and management of financial contributions from sponsors;
- Coordination of service providers and management of logistical communications;
- Preparation of information messages and coordination of projected materials during the Conference;
- Drafting of letters of appreciation and the Conference report;
- Organization and coordination of post-Conference follow-up activities.

In 2025, thanks to the contacts established by Mr. Kevin Hyland, co-organizer of the conference, the CUHD Foundation received donations in connection with the organization of the Human Trafficking Conference from the following donors: The Attorney General Alliance (AGA), the British Standards Institution (BSI), and the Semnani Family Foundation.



OUTLOOK FOR 2026

In 2026, the Foundation plans to focus its efforts on its training mission, emphasizing the development of specialized courses on human trafficking and fundraising to support these initiatives.

In this context, the Foundation is exploring providing partial funding for an online course currently under development. The course is being designed **in collaboration with Ambassador Michel Veuthey and the United Nations Institute for Training and Research (UNITAR)**. Envisaged as a one-year asynchronous programme, the course would take the form of **an English-language MOOC, featuring contributions from experts addressing the various dimensions of trafficking in human beings**. The objective is to ensure the course is free of charge and widely accessible, with a particular focus on stakeholders who may play an active role in prevention and counter-trafficking efforts. While the CUHD Foundation may contribute financially, the project's realisation is contingent on partnerships with additional stakeholders and securing further resources. Should the project be finalised, implementation is expected to be completed **by the end of July 2026**.

In parallel, the Foundation also plans **to support the development of a French-language MOOC**, to be organised **in partnership with Université Nice Côte d'Azur and Ambassador Michel Veuthey**. This course, likewise planned as a one-year programme offered free of charge, would target a broad French-speaking audience. Its content and delivery modalities have yet to be defined.

The Rome Conference on Trafficking in Human Beings, which facilitated the creation of new partnerships and the strengthening of existing ones, also led to the idea of establishing a **Chair on Trafficking in Human Beings at the Pontifical Gregorian University in Rome**. This initiative, still at the project stage and tentatively titled the *"Pope Leo XIV Chair on Human Trafficking,"* would provide an academic platform for teaching, research, and international cooperation on this issue. According to the University's Rector, Rev. Mark A. Lewis, S.J., such a Chair, if established, **could strengthen cohesion among stakeholders engaged in combating trafficking, provide expert advice to international institutions, businesses, law enforcement agencies, and the media, and support high-quality training programmes and conferences**. The Foundation could consider making a limited financial contribution to the financing of this Chair; however, its realisation would depend heavily on additional funding sources and institutional partners.
