Código Penal [Penal Code]

Preliminary Draft of Penal Code as of January 15, 2009

Art. 177.

(Tráfico sexual de pessoas)

Quem, usando de violência, ameaça, ardil, manobra fraudulenta ou aproveitando qualquer relação de dependência ou situação de particular vulnerabilidade de uma pessoa a aliciar ou constranger à prática de prostituição em país estrangeiro ou favorecer esse exercício, transportandoa, alojandoa ou acolhendoa, é punido com a pena de prisão de 2 a 10 anos.

Art. 183.

(Tráfico sexual de menores)

- 1. Quem aliciar menor de 18 anos de idade para o exercício da prostituição em país estrangeiro ou, para o mesmo fim, o transportar, alojar ou acolher ou, de qualquer outro modo, favorecer aquele exercício é punido com pena de prisão de 2 a 10 anos.
- 2. Se o agente usar de violência, ameaça ou fraude, actuar com fim lucrative ou fizer profissão da actividade descrita no número anterior, o menor sofrer de anomalia psíquica ou tiver menos de 14 anos de idade, a pena é de prisão de 3 a 12 anos.

Article. 177.

(Sex trafficking of people)

Who, using violence, threat, deceit, deception or taking advantage any dependency relationship or situation of particular vulnerability of a person to solicit or constrain the practice of prostitution in a foreign country or favor this exercise, carrying it, lodging it or accepting it, is punished with the penalty imprisonment from 2 to 10 years.

Article 183.

(Sex Trafficking of Children)

- 1. About entice younger than 18 years old for the exercise of prostitution in the country abroad or, for the same purpose, the transport, harbors or receives, or in any otherwise favor that exercise is punished with imprisonment from 2 to 10 years.
- 2. If the offender uses violence, threats or fraud, act or make profit profession of the activity described in the preceding paragraph, the lowest suffer anomaly psychic or you are under 14 years of age, the penalty is imprisonment of 3-12 years.

CONSTITUTION OF THE REPUBLIC OF ANGOLA

LUANDA, 21 January 2010

Article 12 (International relations)

- 1. The Republic of Angola shall respect and implement the principles of the United Nations Charter and the Charter of the Organisation of African Unity and shall establish friendly and cooperative relations with all states and peoples on the basis of the following principles:
- a) Respect for sovereignty and national independence;
- b) Equality amongst states;
- c) The rights of peoples to self-determination and independence;
- d) Peaceful solutions to conflicts;
- e) Respect for human rights;
- f) Non-interference in the affairs of other states;
- g) Reciprocal advantages;
- h) Repudiating and combating terrorism, drugs trafficking, racism, corruption and people and human organ trafficking;
- i) Cooperation with all peoples for peace, justice and progress.
- 2. The Republic of Angola shall defend the abolition of all forms of colonialism, aggression, oppression, domination and exploitation in relations between peoples.
- 3. The Republic of Angola shall strive to reinforce African identity and strengthen the work of the African states in enhancing the cultural heritage of the African peoples.
- 4. The Angolan state shall not permit foreign military bases to be established in its territory, notwithstanding its involvement, within the context of regional or international organisations, in peace-keeping forces and military cooperation and collective security systems.
